

**ORDINANCE NO. 2007-11-06-26**

**AN ORDINANCE AMENDING CHAPTER 1, SECTION 14, PARK REGULATIONS, CODE OF ORDINANCES, CITY OF ELGIN, TEXAS; PROVIDING FOR A SAVINGS CLAUSE AND REPEALING CONFLICTING ORDINANCES OR RESOLUTIONS.**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ELGIN, TEXAS, THAT:**

**I.**

That Chapter 1, Section 14, F, Parks and Recreation Department User Fees be amended by adding (4), (5), (6) and (7), Code of Ordinances, City of Elgin is hereby amended to read as follows:

**F. PARKS AND RECREATION DEPARTMENT USER FEES**

(4) Entire Park or Venue

| Elgin Memorial Park     | \$375           | \$750             |
| Thomas Memorial Park    | \$250           | \$500             |
| Morris Memorial Park    | \$187.50        | \$375             |
| Veterans' Memorial Park | \$125           | \$250             |
| *Park and Ride          | \$100           | \$200             |

\* Rental fee of Elgin Memorial Park will include the Park and Ride Facility. Park and Ride can be rented exclusively of Elgin Memorial Park
