B. Community input plan

Parks put up poster displays (community input boards) to engage the public for more input and feedback. Staff is working on another event at Thomas with plans to have another community input board event at Veterans Park based on the phases identified on the Parks Master Plan.

Community Leaders input was received, not as much response was received as expected, but the responses were commensurate from the input from the community at large. Disc golf was showing to be in demand in the top 3 requests. Equipment rentals provided by Parks Dept are helping disc golf and tennis to stay popular and in demand by removing initial high buy in cost to play. Increased/better signage needed at parks. Flag lot parking lot (2<sup>nd</sup> Thomas Park entrance) will hopefully increase park traffic and awareness of amenities.

Movies and music in the park will continue, but most likely on every other week basis. We are trying to schedule city events (like Shop Small Saturday) w/ Parks events to help partner the effort for music and movies. We would like to use the 150-year anniversary of the city of Elgin to bring back the Summer Saturday Series and the Veterans Park project. Positive public comments to city council meetings will help favor changes needed to the parks. As board members, we can ask other community members to also make positive public comments to city council to show a need for more amenities that we are trying to acquire in the PROSMP. Flyers can be distributed from Friends of Elgin Parks that ask for funding or to inform the public of the next council meeting to voice their needs.
